

**COMMENTS: One healthy dog was euthanized due to his having played with a dead bat and later biting a child. As the dog had not received a rabies vaccine and a child was at risk, the dog had to be euthanized for rabies testing. Transferring animals between two shelters at times results in data entry errors. When looking at both shelters data combined, the data shows a 4 cat overage.**
