Four dogs and 10 cats are unaccounted for due to a change in software from Chameleon to Petpoint mid March and then adding a second shelter to the software in Aug. As inventories are completed daily, this can only be due to data entry errors. One healthy cat was euthanized as it did not have a rabies vaccine and was found playing with a dead bat. A child was scratched by the cat leaving ADL testing as the only CQ option. Sadly, Carson City has a high incidence of bat rabies.
